

DIRECTIONS: FROM I-94 East or West, Exit at **EXIT #275 (Cty F, Ixonia-Sullivan)**. Go North on "F" 4 miles to Elmwood Ave. (Cty P). Turn West and follow the road 1/2 mile to Cedar Dr. Turn East on Cedar Dr. and take this into the parking lot. You can also come via 16 from Oconomowoc or Watertown. Cty. F meets Hwy 16 on the North. If you are coming from the East —do not get off at County F in Waukesha County—you need to go 20 miles further on I-94 and get off at exit 275.
